PROJECT LOCATION

The project is located in Washington Township and the City of Centerville. The project limits stretch from the intersection of Social Row Road and Waterbury Ridge Lane, east through the intersections of Social Row Road and Paragon Road, as well as Social Row Road and Sheehan Road, to approximately 1,350 ft east of Sheehan Road. The total length of the project along Social Row Road is approximately 4,650 ft.

REASON FOR PROJECT

The purpose of the project is to alleviate congestion on Social Row Road caused by increased traffic. The current two-lane configuration of Social Row Road does not accommodate existing traffic volumes, nor will it be able to handle anticipated future traffic volumes at the intersections of Social Row Road & Paragon Road as well as Social Row Road and Sheehan Road. Also, gaps in existing pedestrian and bicycle facilities make this section of Social Row Road a barrier for accessing local parks and regional hike/bike trails.

SCOPE OF PROJECT

This project will reconstruct roughly 4,650 feet of Social Row Road from two existing lanes with narrow shoulders to a five-lane curb & gutter section with a sidewalk and shared-use path. The project will include new closed storm drainage, post construction stormwater treatment, and landscaping. Finally, the existing traffic signal at the intersection of Social Row Road and Sheehan Road will be reconstructed, while a new traffic signal will be installed at the intersection of Social Row Road and Paragon Road.

BENEFITS

The Federal Highway Administration's Highway Capacity Manual provides several measures of effectiveness for a transportation facility based on geometric configuration and operational conditions. One such measure is a facility's Level of Service (LOS). LOS is a letter grade that describes traffic operations based on the amount of delay experienced by vehicles at an intersection and along an intersection approach. LOS is measured using letter grades ranging from A (best) to F (worst). The existing unsignalized intersection of Social Row Road and Paragon Road was determined to operate at a LOS F in 2025 and would remain as such if these proposed improvements are not constructed. In addition, the currently signalized intersection of Social Row Road and Sheehan Road operates at a LOS D. If the proposed improvements are not constructed, this intersection is expected to fall to a LOS F by the Design Year 2045. To

provide enough capacity at both intersections and raise these LOS, Social Row Road needs to have two-lanes in both directions and left-turn lanes need to be provided on all approaches of both intersections, including on Paragon Road & Sheehan Road. By constructing these improvements, the LOS improves substantially in the immediate future, and only falls to a LOS D by the 2045 Design Year at the intersection of Social Row Road & Sheehan Road.

In addition to the vehicular benefits, pedestrian and bicycle facilities will also be constructed. These new facilities will fill a gap along Social Row Road between existing facilities found on Paragon Road & Sheehan Road, to those adjacent to Yankee Trace. This connection will provide users with a safe route to Robert F. Mays Park and make a critical connection to other regional hike/bike trails and destinations.

Finally, the new traffic signal at Social Row Road and Paragon Road, as well as the reconstructed traffic signal at Social Row Road and Sheehan Road, will tie all the improvements together by creating safe crossings for pedestrians and bicyclists, as well as helping motorists effectively move through the project corridor.

SCHEDULE

The project is scheduled to begin construction in Summer 2025 with the project completion expected approximately 17 months later.

COSTS

Design: \$1,336,800.00

Right-of-way: To be determined by real estate appraisal

Construction: \$7,800,000.00
Total Estimated Project Costs: \$9,136,800.00


The County has received Federal Grants totaling \$4,531,835 to cover eligible construction projects costs. To help reduce the County's portion of the project, it has partnered with the City of Centerville and Washington Township to share in design and construction costs. Finally, the County will also apply for grant and/or loan funds from the Ohio Public Works Commission (OPWC) in August 2023.

RECOMMENDATIONS

It is the opinion of the Montgomery County Engineer that this project is needed for the safety, convenience, and welfare of the traveling public for the reasons listed above. Also, in the Engineer's judgment, the improvement is necessary to facilitate the right of the public to improvement and maintenance of and uninterrupted travel on roads. I, therefore, recommend that the Board of County Commissioners of Montgomery County, Ohio, find the project necessary pursuant to Chapter 5553 of the Ohio Revised Code, and authorize the County Engineer to proceed with right-of-way negotiations.
