STATE CAPITAL IMPROVEMENTS PROGRAM - SCIP

- Funding provided from general obligation bonds
- Grant & loan money available
- All loans are 0% interest
- Publicly owned infrastructure
- Eligible project types:
 - Road
 - Bridge/Culvert
 - Water Supply
 - Wastewater
 - Solid Waste
 - Stormwater



LOCAL TRANSPORTATION IMPROVEMENTS PROGRAM – LTIP

- Funding provided from gasoline taxes
- Grant only
- Publicly owned infrastructure
- Eligible project types:
 - Road
 - Bridge
 - Culvert



SMALL GOVERNMENT COMMISSION

- Provides Grants & Loans
- Eligibility: Village or township with a population of less than 5,000
- Separate committee and scoring criteria
- Unsuccessful District 4 applications are submitted to the Small Government Commission
- Compete with applications statewide



EMERGENCY PROGRAM

- Defined as projects that are catastrophic situations that threaten health and safety
- \$12 Million/Year total statewide
 - Add'l one-time \$10 million for road slips
- Not for delayed maintenance
- Application submitted directly to Ashley Ellrod
- OPWC Director's discretion to approve





About the Committee

- Member Appointments
 - 2 appointed by BCC
 - 2 appointed by City of Dayton
 - 2 appointed by Greater Dayton Mayors & Managers
 - 2 appointed by Montgomery Township Association
 - 1 appointed by the committee to represent private industry
- Voting 1 vote per appointment
- Quorum of 7 required

FY25 DISTRICT 4 FUNDING

SCIP Grant (maximum)	\$ 6,925,500
SCIP Loan (minimum amount to be awarded)	\$ 769,500
Revolving Loan Program (RLP)	\$ 3,000,000
Local Transportation Improvement Program (LTIP)	\$ 2,666,000
TOTAL	\$ 13,361,000

FY25 SCHEDULE

- Application Deadline:
 - August 23, 2023 by 2pm
 - NO LATE APPLICATIONS ACCEPTED
- Scoring Meeting:
 - November 1, 2023 @ 1pm
- Committee Finalizes Slate:
 - December 6, 2023 @ 2pm
- Slates due to Columbus no later than February 28, 2024
- Agreements Sent:
 - July 1, 2024



APPLICATION REQUIREMENTS

- Must be submitted through Workswise
- Submit only 1 application even if seeking different SCIP/LTIP funding packages
- Fully Executed Authorizing Legislation
- Construction 7/1/2024 6/1/2025

- Use the checklist
- "Applicant" should be person that can answer questions about the application
- Feel free to ask me questions



Application Process

- Initial review / cure period
- Create committee summary
- Scored by committee November 1, 2023
- Slate approved by committee December 6, 2023
- Sent to Columbus for approval
- Agreements sent out July 1, 2024
 - Must be signed within 30 days

Slate Creation Process

- Initial sort:
 - Score, high to low
 - Funding request, low to high
 - Grant request, low to high
- LTIP Minimum funding amounts
 - City \$380,349
 - County \$330,584
 - Township \$177,733
