
This project will replace 4" & 6" cast iron water main on Falmouth Ave, Esmeralda Ave, and St James Ave in Harrison Township with 8" ductile iron water main with all appurtenances. The project will also remove old fire hydrants and replace them with new hydrants with closer spacing. The project seeks to replace the water main which has excessive breaks and has exceeded it's useful life. The pipes being replaced have broken at a rate of 9.1/1000'.

Other Factors


What other factors exist that make this project more important than other like projects?
